A 500-mile GPS guided off-road ride thru the State Forests and Wildlife Mgmt Area's of the New Jersey Pine Barrens, for Adventure Style Motorcycles. This event is pre-entry only and limited to 100 riders, no entries will be accepted after Oct 10th. All bikes must be completely street legal and inspected. DOT knobby tires and a USFS-approved spark arrestor, able to pass the AMA sound test (98 db) are required. Also bikes must be able to go at least 80 miles between gas stops. No Trail Bikes or Two-Stroke.

The start will be at the Hammonton Ramada Inn at 8:00 am Friday Oct 12<sup>th</sup>. AMA membership is required; if you are not a member please signup online at [www.amadirectlink.com](http://www.amadirectlink.com) prior to the event and print out a temporary membership card. The GPS route is property of the Pine Barons Enduro Riders and will be emailed to registered riders. Please do not share or transfer the GPS files.
